I. Order and Roll Call – Steve called the meeting to order at 6:57PM

Board Members Present: Steve Larry – President Glenn Baldwin – Vice President

John Harris – Secretary Dennis Cantrell – Member at Large

II. Pledge of Allegiance

- **III. Motion to Approve Agenda –** Glenn motioned to approve the agenda and John seconded the motion. The board approved the motion unanimously. [05-11-01]
- IV. Motion to Approve 4/12/2011 Minutes Tabled
- V. **Motion to Approve Treasurer's Report –** Glenn motioned to approve the treasurer's report and Dennis seconded the motion. The board approved the motion unanimously. [05-11-02]

VI. Board Member Reports

A. Steve Larry – Steve received Rebecca's report today and will send it out to the board. Dick, Steve, Joe and Rebecca held a team meeting on babbling brook stabilization. They are on track from a budget standpoint. Looking into the future of watershed planning, there is a private property owner upstream of babbling brook, Ed Bettner, that may be taking on a stabilization project in the next year or so and that would benefit the RCD. Dick turned in the bid-letting document to Steve, which he will review and send back with comments and revisions. They are looking to go out to bid in July or August. Dick said that he would like the bid documents to be distributed by Wendler so that they can keep track of who they sent bids to and if a contractor has any questions, Wendler can answer them or send out an addendum if necessary.

Wendler Babbling Brook Stabilization Presentation – On the north side of Babbling Brook, east of the Babbling Brook Bridge they will put in 325' of 6-8 ft high gabion baskets. Going further east, where the wave action is gentler, they will install fiber grids put in w/ plantings and a fiber roll at the tow of the slope. The next area will have more gabion baskets and the last area right through the bend will be RR5 stone riprap. On the south side they will install 9" thick rock baskets, matting with plants, and articulated interlocking blocks. The only work being done in the stream is upon a recommendation from the NRCS to repair an existing rock riffle that is in the stream. Any areas that are disturbed will be replanted or reseeded. They are going to dig down to where the gabion baskets abuts the bridge and take rebar and hand weld it so that they stick out and then they will build up the gabion basket around it. They have to have the building plans submitted to the EPA by the first part of June. In July they will have the final plans ready and hope to go out to bid in August to start the project this fall. All of the materials to be used in the plan adhere to IDOT specifications.

- **B. Glenn Baldwin –** Glenn said that he is going to have Shawn Parish mow the west side properties and Gene Elliot is going to mow the east side and campground. They have worked out set rates for each time they mow the areas. For any other work that they perform, they will charge \$15 an hour.
- **C. Dennis Cantrell Sale of Mowing Equip –** Dennis is going to have Gene Elliott put the mower on Craig's List to sell it.

Playground Mulch – rather than order more mulch to put in at the playground Dennis suggested having the playground go to grass and have Shawn take the existing mulch and consolidate it under the playground equipment.

Mowing RCD Property – A private property owner has mown Schings Park and Dennis wants to send them a letter requesting that they not do that.

D. John Harris – the POA is looking to get a volunteer to be a director of community relations with it being.

Frank Durkin – Goose Management – they oiled 3 eggs in 2 nests. Steve presented Frank with a "Wildlife Manager" jacket.
